ENGAGEMENT OF OPERATIONAL EXPERT ON CONTRACT BASIS

Applications are invited from eligible retired officials of the Food Corporation of India (FCI) belonging to the Depot Cadre for engagement as **Deputy General Manager (Operations)** on a purely contractual basis for assisting JSF&CSCL in monitoring, supervision and coordination of food grain lifting, transportation and movement operations under procurement, storage and public distribution activities.

Number of Positions: 6 (Selected districts/locations of Jharkhand)

Age Limit: 65 Years

Eligibility Criteria

1. Retired official of the Food Corporation of India (FCI) who retired from the post of **Assistant Grade-I (Depot) or above** and possesses experience in depot operations and food grain movement.
2. Having at least 10 years of experience in food grain lifting, stock management, transportation and depot operations.
3. Physically fit and capable of undertaking extensive field inspections and travelling across districts of Jharkhand.

Preference Criteria

In case the number of applications is more than 6, preference will be given to candidates who are/have (preference in the below order):

- Domicile of Jharkhand.
- Experience of working in Jharkhand or in Jharkhand area of erstwhile Bihar.
- Served field postings involving operational supervision and logistics management.

Scope of Work

The Expert shall assist JSF&CSCL in:

- a) Supervising day-to-day lifting operations from FCI depots, warehouses, rice mills and other designated locations.
- b) Verifying availability of stocks and facilitating timely lifting and transportation of food grains.
- c) Coordinating with depot officials, transporters, warehouse personnel and district administration for smooth execution of lifting operations.
- d) Conducting regular field inspections and monitoring movement of food grains from source to destination.
- e) Maintaining both online and offline records relating to lifting schedules, transportation plans, stock movement and operational performance.

- f) Reporting delays, shortages, operational bottlenecks and other issues affecting lifting operations to the concerned authorities.
 - g) Assisting in verification of compliance with operational guidelines relating to handling, transportation and movement of food grains.
 - h) Providing field-level input and recommendations for improving efficiency in lifting and logistics operations.
 - i) Submitting inspection reports and operational updates to the Deputy General Manager (Operations) and JSF&CSCL HQ.
 - j) Any other work assigned by JSF&CSCL and/or the Department of Food, Public Distribution & Consumer Affairs (DFPD&CA).

Place of Deployment

The Expert may be deployed anywhere within the State of Jharkhand and shall be required to undertake extensive travel and field inspections as directed by JSF&CSCL.

Period of Engagement

Initially for a period of three (03) years or until attaining the age of 65 years, whichever is earlier. The engagement may be extended by a further period of up to two (02) years (1+1), subject to requirement, satisfactory performance and the condition that the incumbent has not attained the age of 65 years.

Remuneration

As per Resolution of Finance Department No. 928 dated 06.04.2022, the admissible amount of fixed monthly honorarium/pay (Fixed Pay) shall be equivalent to the last basic pay drawn at the time of retirement minus the amount of basic pension. Dearness Allowance (DA) and annual salary increments shall not be admissible on the fixed pay amount. Payment of Dearness Relief (DR) shall continue to be paid as before. House Rent Allowance (HRA) and Transport Allowance shall be admissible in accordance with Finance Department Resolution No. 1243 dated 28.04.2016.
