



- b) **Paddy Procurement** the Corporation purchases paddy from the farmer after payment of 100% of the Minimum support Price (MSP) at our all twenty four district offices, then the same is milled through rice millers and custom milled rice will deposited to Corporation designated CMR godowns for further distribution of rice under NFSA/JFSS Scheme.

A. Facility:
